- 1. PROMOTION PERIOD:** The Extreme Customs Enthusiasts Giveaway 3 (the "Giveaway") begins on 5/6/2019 and ends at 11:59:59 PM CT on 7/29/2019 (the "Promotion Period"). Extreme Customs LLC's computer is the official time-keeping device for the Giveaway.
- 2. ELIGIBILITY:** This Giveaway is open only to legal residents of the 50 United States and the District of Columbia, who are licensed drivers, 18 years of age or older (and legal age of majority in the state in which they reside). Participants must have a Team Extreme Member ID and must agree to receive email communications from the Sponsor throughout the duration of the Promotion Period.
